# Introduction:

Learn to record, integrate, and report patient data securely through classroom and practical experiences with specialized computer applications. The Health Information Technology A.A.S. prepares you to manage patient data in a diverse range of health care settings.

The program allows you to build credentials in the field. Certificates earned in Medical Billing and in Medical Coding may be applied toward the A.A.S. in Health Information Technology. The Medical Billing Certificate leads to credentialing as a Certified Professional Biller. The Medical Coding Certificate prepares you for certification exams. Each certificate builds your knowledge and skills and helps you advance in the field.

# Medical Billing Certificate Program 1st Certification

Medical Billing job opportunities are expected to grow by 24% in the Hudson Valley over the next 5 years\*

The median salary for a certified Medical Billing professional is \$45,236.\*\*

Medical Billing is the process by which health care providers submit claims to insurance providers (payers), government programs (Medicaid/Medicare), and/or patients directly in order to receive reimbursement for services. Besides invoicing and collecting payments, medical billers are involved with handling denied claims and processing appeals.\*\*\*

Medical Coding is the lifeblood of all successful practices and facilities. Certified medical coders must have a good understanding of anatomy and physiology, the disease process, and clinical procedures in order to apply the correct codes that make up health records, claims and the business side of medicine.\*\*\*

3<sup>rd</sup> Certification and Associate of Applied Science Degree

Median Salary for HIT professionals is \$59,392 \*\*\*

Job responsibilities include ensuring the quality of medical records by verifying the completeness, accuracy, and proper entry into EHR, using the EHR to assemble/analyze patient data for improving patient care and coding of diagnoses/procedures in patient records for reimbursement/research.\*
