Call to Order

Chairperson LeRoy Mitchell called the meeting to order.

B. Board Chair's Report

Trustee Mitchell reported:

Since our September meeting, I attended the dedication of the Student Center in honor of our late past Chair, David Swope in recognition of his enormous contribution to the College, and to its students. The event was very well attended. Among those present were former Congresswoman Nita Lowey and her husband, County Executive George Latimer and former County Executive and former board member, Andrew Spano.

I also participated in a zoom meeting with the leadership of NYCCT. The meeting focused on advocacy for equitable funding for community colleges in New York. We discussed the disparity which exists between the per pupil allocation for the State Ops and the community colleges. A flyer was developed to highlight the situation.

The 54th Congress of ACCT took place in Las Vegas from October 7th thru 12th. At this event, our own President Dr. Belinda Miles, received the Northeast Region CEO Award. Congratulations!

At the conference, I participated in several leadership activities namely, the meeting of the chair's advisory board, where the discussion focused on the mental health and food and housing challenges of the students. We also discussed the new communication tool, ACCT-Connect, which is available free to all member colleges. Indeed, one of the first modules on the site is Trusteeship 101.

There was also a very informative session at the pre-congress event which addressed specifically the issues of the Black Learner. The speakers highlighted the alarming situation in which over 600,000 black students dropped out during the pandemic and have not returned. The speakers suggested that colleges should be intentional in their efforts to help black learners because they are an endangered group.

I was a panelist on the New Trustees and First Time Attendees welcome session. I was also appointed Coordinator of Tellers for the Senate meeting where at-large trustees were elected to the ACCT Board.

At the Northeast Regional Caucus, we were able to elect Allen Williams from Monroe Community College, and current NYCCT Chair to the ACCT Board. NYCCT sponsored a breakfast for the members in attendance. There, we again discussed advocacy for equitable funding for community colleges.

Achieving The Dream sponsored a session on the use of data analytics in pursuit of student success. Dr. Miles and I were invited to join the ACCT/ATD Data Advisory

Committee. There we explored ways in which the use of data can drive certain aspects of student success and thus influence budgeting priorities. The group is comprised of selected presidents and trustees from twelve Community Colleges from around the country together with representatives from ACCT and Achieving the Dream.

We listened to a very informative presentation from Dr. Ben Armstrong, Executive Director and Research Scientist at MIT Industrial Performance Center, during the opening session. He spoke about the place of community colleges in the Work for the Future initiative.

A panel of leaders from industry, business, and academia discussed how business and industry could assist in transforming communities and the role of Community Colleges in the process.

Additionally, I attended sessions on, Bringing Adults back to College; Redesigning Tenure to Advance Black and Brown Student Excellence; Digital Learning Pulse Survey round Table, A Trustee's Role in Advancing Student Success with Equity—A Toolkit.

Resolution: Free Application Weeks

Whereas, the State University of New York (SUNY) is implementing SUNY Free Application Weeks from October 16, 2023 to October 29, 2023 where all new applicants will not have to pay an application fee to apply to a SUNY affiliated institution who uses the SUNY application;

Whereas, Westchester Community College does not use the SUNY application and instead elects to use its own application;

Whereas, Westchester Community seeks to be part of the system-wide efforts to bolster enrollments and provide opportunities for students to both apply to the college who may be otherwise unable to finance the application fee;

Be it resolved that Westchester Community College will waive its application fee for all new applicants, in recognition of SUNY's Free Application Weeks, from October 16, 2023 to October 29, 2023; and

Be it further resolved that this resolution will only apply to new applicants during this time and refunds will not be awarded to students who have already paid application fees.

Resolution: Barnes & Noble First Day Complete

WHEREAS, Barnes & Noble, the sponsors of the WCC Bookstore, offer an equitable access program, known as First Day Complete, wherein all students receive their required course materials, both in physical and digital formats, before the first day of class;

WHEREAS, equitable access models are proven to positively impact student outcomes as students are able to engage with their course content from day one, thus enabling them to be more prepared for class, which can result in higher completion rates across student populations;

WHEREAS, Costs for course materials in First Day Complete are bundled as a student fee, typically saving students on their course materials;

WHEREAS, students will be able to opt out of this new fee should they not want to take advantage of the program;

(Summary of report)

Good afternoon, as President of the WCC Federation of Teachers, our faculty union, I speak on behalf of the faculty, particularly our more than 700 union members at the College.

Yesterday the faculty received an email from Dr. Miles in response to a report I made to our membership on the status of contract negotiations, which have been ongoing for over four years now. I believe that both sides have been bargaining in good faith, and continue to do so. We have painstakingly worked through dozens of complex issues brought by both sides, with a fair amount of success. However, as we now reach the point where we discuss economic proposals on salary, we find ourselves miles apart.

We appreciate the attention Dr. Miles has given to our concerns, and we will continue to bargain with the College in good faith on this and all other negotiating items. But my hope is that my remarks today have underscored the urgency of our needs, and that the College will make real the respect and admiration it voices, in the form of salary increases that will keep our collective "heart" strong and healthy. We would be grateful for any support you could show for our faculty in this regard.
