TEXTBOOK RENTAL AGREEMENT

The in-store Textbook Rental Program allows students attending Westchester Community College the opportunity to rent selected textbooks for the duration of a single semester. A valid Student ID # and an accepted, valid personal credit card, whose expiration date must exceed the end of the rental agreement, is required at the time of renting the specific book(s) and the rental fees associated therewith are set forth on the attached rental form which is incorporated herein by reference. **The FSA Bookstore does not accept American Express.**

Terms of Agreement

1. **By signing this form, I acknowledge I am at least 18 years of age. I Hereby agree to accept and abide by the following terms and conditions and understand that the book(s) rented by me is/are the property of the FSA Westchester Community College Bookstore or their rental partner Follett Corporation and in accepting the terms of this rental program, I accept the responsibility to appropriately use the book(s) and return it/them to the FSA Bookstore in re-sellable condition.**
2. **You authorize The FSA Bookstore or the Follett Corporation to share details of your rental transactions with the College, University, or School at which you are enrolled and you acknowledge that your College, University, or School may provide The FSA Bookstore or the Follett Corporation and its third party collection agency with contact information, including but not limited to, your e-mail address, home address, home telephone number and cellular telephone number, which may be different than the information you provided to us, for the purpose of contacting you regarding failure to return Rented Materials or open non-return fees.**
3. **I understand and accept the responsibility that at the end of each semester, it is my responsibility to return the book(s) rented under this program or pay the replacement price of the book(s) in my possession, and or any late fees. The book(s) must not be water damaged, missing content, stained or in unusable condition. Limited highlighting is permitted.**
4. **I understand and agree that the FSA Bookstore will have the sole discretion to evaluate and determine the condition of the book(s) upon return.**
5. **Failure to Return: If I fail to return the Rental textbook(s) by the last day of finals, or return them in an unsaleable condition. I authorize FSA Bookstore to charge a late fee and a replacement price of the textbook less any rental fee charged to my credit card or debit card used to rent the book(s). "Replacement price" is based on the new book price at the time of rental. You may not be eligible to use the Rental Program in the future.**
6. **I understand that if the rented book(s) are not returned associated penalties may be assigned collection by a third party agency. FSA Bookstore has the right to put my student records on hold which will not allow me to receive my transcripts or diploma until the book(s) is returned or the price to replace the book(s) is paid.**
7. **I understand that my rental fee is refundable only if the book is returned within the posted textbook return period as described under the Return Policy which is within five (5) days of purchase for the first three weeks of Fall and Spring Semesters and one week of Summer semesters.**
8. **I understand that rental textbooks are the intellectual property of the author(s) and are copyrighted by the author(s) or publisher(s). Textbook rentals are not to be reproduced.**
