



## Yonkers Extension Center

The Center is located on the fifth floor of the Cross County Office Building. The lobby entrance is between the two banks, adjacent to the Express store entrance, and across the street from Sears.

### DRIVING DIRECTIONS

#### Southbound -

- Sprain Brook Parkway to Cross County Parkway West to Exit 5, Midland Avenue.
- Bronx River Parkway to Cross County Parkway West to Exit 5, Midland Avenue
- Hutchinson River Parkway to Cross County Parkway West to Exit 5, Midland Avenue.  
From Cross County Parkway West, take Exit 5, Midland Avenue: Right turn off exit ramp after Stop. Right turn at light. Go through next light. Right at next light, and into the Center. Left at Stop sign. Park near Express and office building on right.
- NYS Thruway to Exit 4. Merge onto Central Avenue (RT 100) southbound.  
From Central Avenue (RT 100) southbound: Left on to Mile Square Road at 1<sup>st</sup> traffic light. Left at next light on to Central Avenue northbound. At next light, make right turn into Cross County Shopping Center. (Don't go into the 1<sup>st</sup> Mall entrance.) Pass through Stop sign, make a Left at traffic light. Park near Express and office building on left.
- Saw Mill River Parkway to Cross County Parkway East, Exit 5, Midland Avenue.  
From Cross County Parkway West, take Exit 5, Midland Avenue: Right turn off exit ramp after Stop. Right at next light, and into the Center. Left at Stop sign. Park near Express and office building on right.

#### Northbound –

- Bronx River Parkway to Exit 11 Cross County Parkway West to Exit 5, Midland Avenue.
- Hutchinson River Parkway to Cross County Parkway West to Exit 5, Midland Avenue.  
From Cross County Parkway West Exit 5, Midland Avenue: Right turn off exit ramp after Stop. Right turn at light. Through next light. Right at next light, and into the Center. Left at Stop sign. Park near Express and office building on right.
- Henry Hudson Parkway (Saw Mill River Parkway) to Cross County Parkway East, Exit at Central Avenue (RT 100) southbound. Left on to Mile Square Road at 1<sup>st</sup> traffic light. Left at next light on to Central Avenue northbound. At next light, make right turn into Cross County Shopping Center. (Don't go into the 1<sup>st</sup> Mall entrance.) Pass through Stop sign, make a Left at traffic light. Park near Express and office building on left.
- Major Deegan (I-87 NYS thruway) to exit 3, Central Avenue northbound. Make a right at the Cross County Shopping Center traffic light. (Don't go into the 1st Mall entrance.) Pass through Stop sign, make a Left at traffic light. Park near Express and office building on left.
