



Ossining Extension Center Mental Health Technician Summer-2010

Thank you for your interest in Westchester Community College's Certified Mental Health Technician Program (CMHT)

This 80-hour course will prepare you to understand basic psychiatric terminology, psychopathology, social skills training, and mental health laws and ethics. Your communication skills and professional interactions with patients will be valuable assets. Certified Mental Health Technicians (CMHT's), also called psychiatric aides, can enjoy job security, higher salary, and unique job opportunities. CMHT's are part of a patient-centered team for individuals who may be mentally challenged or emotionally disturbed, or for psychiatric patients under the supervision of a psychiatrist, registered nurse, or social worker.

Course topics include:

- Psychiatric Terms
- Involuntary Admission
- Mental Health Organizations
- Psychopathology
- Professional Disciplines
- Voluntary Admission
- Patients rights and responsibilities
- Ethics
- Management of Aggressive Behavior
- Communication with Medical Professionals
And Therapists

Cost: The cost for the program is **\$1200.00**, which may be paid in full or in three payments paid before the start of each module (see payment schedule on the next page).

The non-refundable application fee is \$20 and must be submitted with the completed application. The following costs can also be expected: \$15 for malpractice insurance (required), cost of uniforms and textbooks, and the fee of \$105.00 for the National Health career Examination.

**Certified Mental Health Technician Program
Directions for Completing the Application
Summer 2010**

1. Complete and mail **application for admission** with *non-refundable* \$20 application fee. Checks or money orders should be made out to "Westchester Community College." *The application for the Summer 2010 Certified Mental Health Technician is due on or before **May 20, 2010**.* The recommendation may be submitted at a later date, but must be received before the first day of class. Mail the completed application to

2. Complete top half of **recommendation form** and submit to individual who will be completing the reference, along with an addressed, stamped envelope. The envelope should be addressed to the address identified in #1 above.
3. Obtain a physical examination from a licensed physician and submit the **physical examination record** *by the first day of the Interview*. You *do not* need to mail the physical examination record with the application.
4. Once your application is received, you will be scheduled for an interview and, if necessary, a reading exam. All candidates must successfully complete the screening interview prior to acceptance to the program.
5. Tuition Payment Options: The tuition for the Certified Mental Health Technician Program is \$1200.00 This tuition may be paid in full by June 1, 2010* or may be paid by module according to the following schedule:

Students must successfully complete all three modules and fulfill all financial responsibilities to Westchester Community College in order to be eligible to take the New York State Certified Mental Health Technician Examination.

**The number of individuals accepted into the CMHT Program is limited. Acceptance is based on date of program application and the personal interview. Payment for Module 1 is due no later June 1, 2010. If payment is not made by 06/01/10, your seat in the CMHT Program will not be held.*
