Enrollment Update:

Instruction for our final fall 2022 session -7.5 week - begins on Monday, October 24. To meet students where they are, we offered $\underline{5}$ sessions this fall: 15-week; 14-week, 12-week, and two 7.5-week sessions.

Registration for Winter 2023 and Spring 2023 begins on October 31.

- Fall 2022 Enrollment:
- As of October 18, 2022, fall 2022 enrollment is 8,803 which is a 2.9% decline compared to fall 2021 during the same time.

Our Strategic Enrollment Team remains focused on attracting new students to the college and retaining continuing students through targeted messaging and student engagement initiatives.

RESOLUTION: SUNY Free Application

Whereas, the State University of New York (SUNY) is implementing SUNY Free Application Weeks from October 24, 2022 to November 6, 2022 where all new applicants will not have to pay an application fee to apply to a SUNY affiliated institution who uses the SUNY application;

Whereas, Westchester Community College does not use the SUNY application and instead elects to use its own application;

Whereas, Westchester Community College seeks to be part of the system-wide efforts to bolster enrollments and provide opportunities for students to both apply to the college who may be otherwise unable to finance the application fee;

Now, therefore, be it resolved that Westchester Community College will waive its application fee for all new applicants, in recognition of SUNY's Free Application Weeks, from October 24, 2022 to November 6, 2022; and

Be it further resolved that this resolution will only apply to new applicants during this time and refunds will not be awarded to students who have already paid application fees.
