- SUNY Film Festival Awards:
 - Digital Filmmaking student Paulina Jaskiewicz received the Grand Jury Award for her film, "Wide Open Dreams." Of special note: while several WCC students have had their films accepted into the Festival, Paulina is the first WCC student to win an award and the only community college student in the festival's 11-year history to win the prestigious Grand Jury Award!

PepsiCo Campus Visit:

Members of PepsiCo's national leadership and Senior PepsiCo Foundation representatives will visit our Valhalla campus early next month to meet a few of our *Uplift/SMILE* student scholars. We are especially honored by their request to visit, especially since they refer to WCC as their "flagship" campus in the Uplift program.

Accreditation

Middle States Self-Study

- Dr. Robert Bonfiglio, Middle States Commission on Higher Education, Vice President for Institutional Field Relations conducted meetings today with our college community as part of our Self-study process. We thank all who participated or attended the Open Session. This is a critical first step in our self-study preparation.
- Two to three BOT members will liaise regularly with the self-study core team.
 - John Nonna and Deborah Raizes have volunteered to be part of the team
- Joint Advisory Statement on Boards and Accreditation, March 31, 2022
 - "Board members lack a solid understanding of what accreditation is,"
 says a report issued by AGB and CHEA in the face of stress on the system.

This is not the case at Westchester Community College. Our board members are engaged.

Chancellor Search

 Kristine Duffy, President, SUNY Adirondack, Chair, New York Association of Community College Presidents (NYCCAP) has been appointed to be part of the Chancellor search.

Guided Pathways Institute

• The Institute is taking place virtually this week. I am planning on attending some of the sessions. Trustees Nonna and Raizes will also attend some of the sessions.

New York State Budget

- Highlights include:
 - No reductions to 2021/22 Direct State Tax funding levels, for any programs or campuses
 - Increased levels of capital investment (\$660.0M above the annual \$550.0M), \$53.0M in support for new Full-Time Faculty and benefit costs, and support for growth in programs such as EOP, Maritime Scholarships, and Mental Health
 - Increased investment in New York State's students, through expansion of the Tuition Assistance Program (TAP) for part-time students, returning the ability for incarcerated individuals to receive TAP, and removing work requirements for childcare subsidies for students
 - Elimination, in a single year, of the existing SUNY Tuition Credit (TAP Gap)
 as well as elimination of the "Excelsior Tuition Rate Lag" by re-setting the
 rate of tuition charged to Excelsior scholarship recipients to 2022/23

- levels, which will then re-set annually to current year levels; an approximate \$62.0M benefit to SUNY Schools
- Reduced debt service requirements on our SUNY Hospitals, and one-time investment in childcare (\$10.8M) and campus/college/hospital operations (\$60.0M) that are intended to increase enrollment, strengthen academic programs, and support the evolution of the SUNY System.

NYCCT

Resolution: Approval of the 2022-23 College Operating Budget with Tuition and Fee Increases

WHEREAS, Westchester Community College seeks to provide accessible, high quality and affordable education and related services to meet the needs of its diverse community; and

WHEREAS, Westchester Community College must balance financial stability with affordability to ensure the continued success of its mission; therefore, be it

RESOLVED, that the Board of Trustees of Westchester Community College herewith approves the College's 2022/23 Unrestricted Operating Budget Request in the amount of \$101,424,000; and be it further

RESOLVED, that the Board of Trustees of Westchester Community College authorizes a tuition increase of Fifty Dollars (\$50.00) per semester from Two Thousand Three Hundred Sixty-Five Dollars (\$2,365.00) to Two Thousand Four Hundred Fifteen Dollars (\$2,415.00) for full-time credit courses and an equivalent increase of 2.1% for part-time credit courses; be it further

RESOLVED, that the Board authorizes the following fee increases effective Fall 2022: 3% increase in Children's Center fees; an increase in the Student Activity Fee from \$7.50 per credit to \$8.50 per credit up to a maximum of 12 credits; an increase in the Student Services Fee from \$4.00 to \$4.50 per credit up to a maximum of 12 credits; establishment of a \$50 fee for students electing a Bursar Deferment.

BOT Policy on Ethical Governance

Resolution - POLICY on ETHICAL GOVERNANCE

WHEREAS, Section 6306 of New York State Education Law establishes community college boards of trustees and delineates the number, term, appointing authorities, and powers of trustees; and

WHEREAS, In New York State, community college trustees are public officials subject to NYS Public Officers Law, and in Westchester County, community college trustees are subject to Westchester County Code of Ethics.; and

WHEREAS, By law, trustees of Westchester Community College take an oath of office to abide by these regulations. To create an environment that supports collegial and productive board leadership,

NOW, THEREFORE, BE IT RESOLVED the Trustees of Westchester Community College supplement the state and county laws by endorsing the ACCT Guide to Ethical Governance as an expectation for professional conduct and ethical responsibility of board member service at Westchester Community College.
