INFORMATION AND DECISION

A. President's Report

Dr. Belinda S. Miles reported:

President Miles gave updates on the following:

While this first meeting of our academic year is remote, we have more and more students and employees returning to campus. We expect our in-person presence to grow as the semester continues.

We continue to monitor the pandemic daily. Numbers look strong – decreasing rates of COVID infections and increasing rates of vaccinations. Our on-campus student population is quickly complying with vaccination/exemption requirements. Likewise, many employees are back on campus for at least part of the week and are either vaccinated or participating in weekly testing.
