SUNY Westchester Community College has been awarded \$3,597,836 of HEERF funds (Grant P425E201126) from the Department pursuant to the Certification and Agreement for **Emergency Financial Aid Grants to Students**.

SUNY Westchester Community College has also been awarded \$3,597,836 of HEERF funds from the Department pursuant to the Certification and Agreement from the **Institutional Portion.**

The total funds awarded under the 18004(a) (1) allocation to date is \$7,195,672.

4. Estimated Total Number of Eligible Students

SUNY Westchester Community College has determined an estimated total of <u>4,396</u> students at the institution are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

5. Total Number of Students Received Emergency Financial Aid Grant

There are <u>829</u> WCC students that have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act as of the <u>25 June 2020</u> (First 45 day Report). WCC received SUNY System final policy and procedure approval for the distribution of the Student Emergency Financial Portion of HEERF Cares Act funds.

6. Method to Determine Emergency Financial Aid Grants

SUNY Westchester Community College has prioritized awarding of Emergency Financial Aid Grants to its students in the following manner:

Priority 1 - Pell recipients

70% of the funds received will be used to meet the emergency need of students impacted by COVID-19 in this category.

Priority 2 – Eligible Non-Pell recipients

25% of the funds received will be used to meet the emergency need of students impacted by COVID-19 in this category.

Extra funding – Eligible students in special circumstances

5% of the funds received will be used to supplement amounts of the max awards of \$1,000 for students who have special circumstances and a particularly pressing need (up to Pell max of \$6,195 per award).

Under Section 18004(a)(1) of the CARES Act, students may receive awards ranging from \$500 to \$3,000, with additional awards available up to the maximum Federal Pell grant threshold of \$6,195 per award.

7. Institutional Instructions, Directions, or Guidance to Students

SUNY Westchester Community College has distributed the following communication to students:

<u>To WCC Students</u>: To address the needs created in these unprecedented and challenging times, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was signed into law to get support to college students in need of relief as quickly as possible. Funding is prioritized to help cover your expenses related to the disruptions of campus operations due to coronavirus. To be eligible for this funding, the student must

- have been enrolled in the Spring 2020 semester in at least one in-person class as of March 13, 2020,
- have completed a 2019-20 FASFA or a 2020-21 FASFA and meet the eligibility requirements to receive Title IV federal financial aid,

Funding for Fall 2020 students will be eligible if funds are available. (cont.)
