Dear Friends,

We are pleased to present this report on our 2007 graduating class. The 1,150 students who received degrees were drawn from all six cities and nineteen towns in Westchester county and reflect closely the demographic characteristics of the county in terms of gender and ethnic background.

Our graduates are continuing their education at 44 colleges throughout the United States. In total, almost three-fifths (59.1%) of the respondents transferred to a four-year college, and nearly three-fourths (71.5%) are attending full-time.

Three-fourths (75.4%) of the respondents also are employed either full-time or part-time. They are employed by 89 different companies in Westchester County; another 32 companies in New York State, but outside the county; and an additional 7 firms located in other states. The mean salary for those holding full-time jobs was \$40,190. The median salary was \$30,000.

The evaluation by the graduates of the college and the services it provides continues to remain high. In evaluating the *Overall Quality of Instruction* at Westchester Community College, 97.8% were either *very satisfied* (65.8%) or *satisfied* (32.0%). With regard to their *Overall College Experience*, 96.1% were either *very satisfied* (77.6%) or *satisfied* (18.5%).

The accomplishments of our graduates are a great source of pride to us. We believe you will share these feelings as you read this report.

EXECUTIVE SUMMARY

The graduates of Westchester Community College who responded to the 2007 Graduate Survey reported a decrease in salaries over the graduates of previous years. The mean salary for those employed full-time is \$40,190, down by \$3,663 from the previous year (\$43,853). Three-fourths (75.3%) reported being employed after six months, which is higher than the previous year's graduating class (71.4%).

Employment: The 2007 graduates continued to feel positive about their jobs.

Satisfaction with Job: Over four-fifths (84.2%) of the graduates who responded were either *very satisfied* or *somewhat satisfied* with their jobs, and over three-fourths (77.1%) also were either *very satisfied* or *somewhat satisfied* with their *Opportunity to Advance*. Four-fifths (80.3%) further felt that their education at the college prepared them for their current job either *to a great degree* or *to a slight degree*.

Location of Employment: Over two-thirds (69.5%) of the 2007 graduates who reported being employed were employed in New York State. Over half (51.1%) of the graduates who reported they were employed found employment in Westchester county. Another 18.4% of the graduates were employed outside Westchester, but inside New York State, while 4.0% found employment outside the state. The location of employment for 26.4% could not be determined.

Education: The percentage of the graduates who reported that they transferred to a fouryear college increased slightly this year, with 59.3% of the graduates reporting they had transferred to a four-year college compared to 58.3% of the 2006 graduates.

Attending College Full-Time: Of the respondents who reported continuing their education, almost three-fourths 71.5% reported attending college *full-time*. This is a slight decrease from last year's class (73.8%).

Degree Aspirations: As in previous years, a high percentage of the respondents (76.8%) intend to obtain a bachelor's degree or even a post baccalaureate degree. This percentage is lower than the previous year's percentage of 87.5%.

Factors Facilitating Transfer: Responses to a set of questions exploring factors important to facilitating student transfers showed that the ones considered *very important* by the largest percentage of respondents are: *Availability of Program Desired* (76.6%), *Location and Cost* (76.1%), and *Reputation of College* (65.5%).

Demographic Characteristics: A review of the demographic characteristics of the entire Class of 2007 reveals only slight changes from previous graduating classes.

Gender: The percentage of female graduates decreased slightly from 59.1% in 2006 to 58.4% in 2007.

Ethnic Background: The percentage of Black graduates (18.9%) increased slightly compared to last year's class (17.5%), while the percentage of Hispanics increased to 19.3% from 15.7%.

Age: The percentage of students graduating under the age of twenty-two (22.9%) increased slightly over last year's class (21.6%). The percentage of graduates in the 22 to 29 age group (45.5% in 2007) decreased compared to 49.2% in 2006.

Reasons for Attending: Almost half (45.9%) reported that their major reason for attending Westchester Community College was to *Increase My Chances to Get a Specific Job or a Better Job*. Over one-fourth (31.1%) did so in order to transfer to a four-year institution. The remaining fifth (23.0%) did so to *Reach Other Goals Such As Self-fulfillment*.

Evaluation of College Experience: The respondents to the survey continue to give a positive response on several broad questions concerning Westchester Community College.

Overall College Experience: As in previous years, the overwhelming majority (96.1%) of the 2007 graduates were either *very satisfied* or *satisfied* when asked about their *Overall Westchester Community College Experience*. With regard to the *Quality of Instruction*, 97.8% reported being either *very satisfied* or *satisfied*.

Courses in Major: In evaluating courses in their major, the majority of respondents (96.0%) were either *very satisfied* or *satisfied*. This percentage is slightly lower than the previous year (96.7%).

Availability of Courses: This year, a slightly lower percentage (90.2%) expressed satisfaction with the *Availability of Courses*, than last year's graduating class (93.8%).

Goals met by College Degree: Over four-fifths of the graduates (86.6%) felt their goals were met by their college experience.

Evaluation of Student Services: In another series of questions, respondents were asked to rate their satisfaction with eighteen of the college's services. The services to which the students gave the most *very satisfied* responses were: *Library Services* (75.3%), *Computer Services* (73.6%), *Reading and Math Skills Facilities* (58.4%), *Advising by Academic Faculty* (58.2%), and *Financial Aid* (55.2%).

Effectiveness of the College in Helping to Achieve Goals of Respondents: A large percentage of the respondents indicated that their goals had been met by their college experience.

Employment Goals: For the six questions exploring job-related goals, almost ninety percent of the respondents consistently indicated that Westchester Community College had been either *very effective* or *somewhat effective* in helping them to achieve these goals.

Transfer Goals: Of the graduates who cited *Transferring to a Four-year Institution* as a major goal, 94.7% indicated that Westchester Community College had been either *very effective* or *somewhat effective* in helping them to achieve this goal.

Academic Goals: The 2007 graduates were also asked a series of questions about their academic goals. Of the students who cited *Increased Knowledge and Understanding* as a goal, 82.5% rated Westchester Community College very *effective* and another 14.9% rated it *somewhat effective* for a total of 97.4%. Of the 2007 respondents, 76.2% rated Westchester Community College very *effective* in helping to achieve their goal of *Increased Desire and Ability to Learn* with another 21.1% rating it *somewhat effective*, for a total of 97.3%.

Personal Goals: Over two-thirds of the graduates considered achieving personal growth as a part of their reason for attending Westchester Community College. Of the eight sub-goals listed, 94.4% felt Westchester Community College had been either *very effective* or *somewhat effective* in *Improve Self-Confidence* and 93.5% in *Develop a Sense of Responsibility*.

The results of the survey are based on the responses of the 231 graduates, which represents almost 20.1% of the entire graduating class of 1,150 students. We are grateful to these students for their cooperation. The responses are a valuable tool for planning and assessment as Westchester Community College strives to provide quality services and instruction.

THE GRADUATES OF 2007

The 2006-2007 Study of the Graduates of Westchester Community College provides information about the 2007 graduating class in three ways. First, it profiles the demographic, educational, and work-related characteristics of these graduates. Secondly, it compares these graduates to graduates in previous years to identify trends existing among our recent graduates. Thirdly, it provides the results of an evaluation by the graduates of the services and resources offered at Westchester Community College, along with an evaluation by the graduates of the effectiveness of Westchester Community College in helping them to achieve these goals. These evaluations are used by the faculty and administrators of the College for planning and assessment purposes.

METHODOLOGY

In Fall 2007, a survey (see Appendix 13) was sent to students who graduated from Westchester Community College either in the late summer of 2006, December 2006, or the spring of 2007, otherwise considered the graduating Class of 2007.

Of the 1,150 students who graduated in the Class of 2007 (995 with Associate degrees and 155 with certificates), a total of 231 returned a completed, usable survey. This yielded a sample size of 20.1%.

A comparison of the respondents to the known demographic characteristics of the entire 2007 graduating class shows similar percentages with regard to ethnic background, gender, and residence. For example, 46.3% of the respondents are White, while White students comprise 52.1% of the actual graduating class; 22.1% of the respondents are Black compared to 18.9% of the actual graduating class; and 21.2% of the respondents are Hispanic compared to 19.3% of the actual graduating class. With regard to gender, 29.0% of the respondents are male, while males comprised 41.7% of the actual 2007 graduating class. Additionally, 8.2% of the respondents live in the Bronx, while 9.2% of the actual class lived in the Bronx; over two-thirds (77.1%) of the respondents live in Westchester.

In certain instances, the total number of students responding to a question does not add up to the total number who returned the survey (231). This is due to the fact that some respondents failed to answer a question or responded to a question that was not applicable to their current status. In these cases, we have used the actual number of respondents.

DEMOGRAPHIC PROFILE OF ENTIRE CLASS OF 2007

Gender: Almost three-fifths (58.4%) of the graduating class of 2007 are female, as shown in Table I. This represents a slight decrease from the previous year.


Age: Over one-fifth (22.9%) of the 2007 graduates were under twenty-two years of age at the time of graduation which was slightly higher than the Class of 2006 (21.6%), as shown in Table I. The percentage of students graduating between the ages of twenty-two and twenty-nine decreased from (49.2%) in 2006 to (45.5%) in 2007.

2007 GRADUATES BY AGE




Ethnic Background: As shown in Table II, over half of the graduates are White (52.1%), 18.9% are Black, 19.3% are Hispanic, and 4.8% are Asian/Pacific. The percentage of graduates who are classified as Non-Resident Aliens is 3.4%.

GRADUATES BY ETHNIC BACKGROUND – 2007




Degrees: Almost two-fifths of the graduates (39.7%) received an AAS degree. The AAS degree continues to be the top degree awarded. Over one-quarter (30.8%) graduated with an AA degree, and approximately one-sixth (16.1%) received an AS degree. The percentage of students receiving a certificate degree has remained consistence at 13.5%.

GRADUATES BY DEGREE: 2003-2007




EMPLOYMENT PROFILE OF 2007 GRADUATES

<u>Class of 2007:</u> Over three-fourths (75.3%) of the 2007 graduates who responded reported being employed, as shown in Table IV. Of those employed, 67.2% reported being employed full-time and 32.8% employed part-time.

Location of employment: Of the respondents who reported the location of their employment, almost half (51.1% or 89 graduates) reported working in Westchester County. Less than one-fifth (18.4% or 32 graduates) reported working in New York State, but outside Westchester County, bringing the total percentage of those working in New York State to 69.5%. Another 4.0% reported working outside New York State. The work location of 26.4% of the respondents could not be determined.

Salary: The *mean salary (average)* for the 2007 graduates employed full-time was \$40,190. The median salary was \$30,000. Three-fifths of these graduates (60.1%) reported being either *very satisfied* (15.2%) or *somewhat satisfied* (44.9%) with their salary, as shown in Table V.

Job Satisfaction: More than four-fifths (84.2%) of the respondents also reported being either *very satisfied* (38.3%) or *somewhat satisfied* (45.9%) with their jobs, while 10.4% of the respondents reported being *somewhat dissatisfied* and another 5.4% reported being *very dissatisfied*, as shown in Table V below.

Opportunity to Advance: Over three-fourths (77.1%) of the respondents felt either *very satisfied* (45.7%) or *somewhat satisfied* (31.4%) with their opportunities for advancement. This is slightly lower than last year's graduates, where more than four-fifths (80.2%) respondents expressed some degree of satisfaction.

Westchester Community College's Impact on Employment: Over half (52.2%) of the respondents felt that *Finishing Their Degree* had been an important function in getting their current job. Of those who reported their employment status, 45.3% also felt that their *Specific Program of Study* was *important* to getting their current job.

A total of 67.5% of respondents reported that their current employment was to some degree related to their course of study. Almost two-fifths (38.7%) of the employed respondents indicated that their current occupation was *highly related* to their program of study at the college, and almost one-third (28.8%) indicated that it was *slightly related*.

While one-third 32.5% indicated that their current job was *not related* to their program of study at the college, over three-fourths (80.3%) of the respondents felt that their Westchester Community College education prepared them for their current job either to a *great degree* (47.9%) or to a *slight degree* (32.4%).


<u>Class of 2007 Employment Status Compared to Previous Classes:</u> Considerable decrease is seen in the mean beginning salary of the employed graduates when comparing the 2007 graduating class with previous year. The mean beginning salary decreased to \$40,190 from \$43,853 in 2006 as shown in Table VI.

The percentage of respondents working in Westchester County remains relatively stable at 51.1%.



The Class of 2007 survey results show a higher percentage employed than the previous year. As shown in Table VII, 75.3% of the 2007 graduates reported being employed, compared to 71.4% in 2006. The percentage of those working full-time, decreased slightly from 71.0% in 2006 to 67.2% in 2007. The percentage still seeking employment increased from 7.5% in 2006 to 10.0% in 2007.

EDUCATION PROFILE OF 2007 GRADUATES

<u>Class of 2007</u>: Nearly three-fifths of the respondents (59.3%) or 137 graduates reported attending a college, university, or training program, as shown in Table VIII. Of these students, 71.5% reported attending full-time.

Demographic Characteristics of Those Attending College: Of the 2007 graduates who reported continuing their education, 70.8% were female; 44.5% were White; 19.7% were Black, and 23.4% were Hispanic, as shown in Table IX.

The College's Contribution to Achieving Transfer: The 2007 graduates consider Westchester Community College to have been very effective in assisting them to transfer. Of those respondents who indicated *transferring* was a goal, almost three-fourths (72.6%) reported that the college was either *very effective* (58.4%) or *somewhat effective* (14.2%) in helping them to achieve their goal of transferring to a four-year institution.

When graduates were asked how well Westchester Community College prepared them for further study, over three-fourths (72.8%) indicated that they felt *well prepared*, and another 26.0% felt *somewhat prepared*. Very few (1.2% or only two graduates) reported feeling *unprepared*.

A large percentage reported being in a field of study either *highly related* (61.4%) or *slightly related* (26.2%) to their program of study at Westchester Community College. 12.4%, however, reported being in a field of study *not related or applicable* to their program of study at the college.

Four-Year College's Contribution to Affecting Transfer: The 2007 respondents were asked to rate the most important factors affecting their decision to transfer to a four-year college. The three factors with the highest percentage of respondents rating them *very important* were: *Availability of Program* (76.6%), *Location and Cost* (76.1%), and *Reputation of College* (65.5%). The least important factor was *Recruitment by College* (27.1%), as shown in Table X.


Future Educational Goals: Lower percentage (76.8%) of the respondents who are continuing their education expect to earn a bachelor's degree or post baccalaureate degree at the completion of their studies than those in the previous year (87.5%), as shown in Table XI.

<u>Class of 2007 Higher Education Status Compared to Previous Classes:</u> A comparison of the 2007 graduates to the four previous classes with regard to continuing their education shows that the percentage who are continuing their education (59.3%) has increased from the previous year (58.3%). In addition, the percentage attending full-time decreased slightly -71.5% this year compared to 73.8% last year.

STUDENT EVALUATION OF ACADEMIC EXPERIENCES

Overall Evaluation: Survey respondents continue to give positive feedback in their overall evaluation of the college, the faculty, and the courses they took in their major, as shown in Table XII. Of the 2007 graduates (97.8%) gave a very satisfied or satisfied response to the Overall Quality of Instruction. A large percentage of the graduates (96.7%) also were satisfied or very satisfied with Library Services, 96.1% were either satisfied or very satisfied with Overall Westchester Community College Experience, and (96.0%) gave a very satisfied or satisfied response to their Courses Taken in Their Major.

Table XIII further breaks down the evaluations for the Class of 2007 into the more specific responses of *very satisfied*, *somewhat satisfied*, *somewhat dissatisfied*, and *very dissatisfied*. Over three-quarters (77.6%) of the respondents gave a *very satisfied* response to their *Overall Westchester Community College Experience*. Almost three-fourths (75.3%) of the respondents also were *very satisfied* with the *Library Services*.



Degree of Preparation for Further Study: Table XIV shows that of the respondents who evaluated the extent to which Westchester Community College had prepared them for further study, almost three-fourths (72.8%) felt that they were *well prepared*. Another one-fourth (26.0%) felt *somewhat prepared* and 1.2% felt they were *not at all prepared*.

The evaluation by students of college services shows that the graduates were particularly positive about Library services. It received the highest percentage of *very satisfied* responses (75.3%). Computer Services (73.6%), Reading and Math Skills Facilities (58.4%), Advising by Academic Faculty (58.2%), Financial Aid (55.2%), Tutorial Services (54.3%), and Registration (54.2%), also received high percentages of *very satisfied* responses.

Those services receiving the greatest percentage of *very dissatisfied* responses were Cafeteria Food Services (9.1%), Job/Career Services (9.0%), Advising by Counseling Faculty (8.9%), and Counseling Services (8.0%).


In terms of usage, the services reported being used by the most respondents were Registration (95.6%), Admissions Services (95.1%), Advising by Academic Faculty (93.8%), and Computer Services (92.6%). The services reported used by the least number of respondents were Health Services (45.6%), Job/Career Services (48.9%), Recreational and Athletic Facilities (58.3%), and Financial Aid (59.4%).

EFFECTIVENESS IN STUDENT GOAL ATTAINMENT

Westchester Community College graduates were asked what best describes their most important reason for earning a college degree. Table XVI shows that almost one-half (45.9%) of the 2007 respondents selected *To Increase Their Chances of Job Placement or Advancement*. Over one-fourth (31.1%) chose *To Prepare to Transfer to a Four-Year College*, and over one-fifth (23.0%) selected *To Reach Other Goals Such As Self-Fulfillment*.

Academic Goals

Goal of Increased Knowledge: Table XVII shows that on each of the six questions exploring the success of the college in helping graduates to achieve their academic goals, over ninety percent indicated on each sub-goal that Westchester Community College had been either *very effective* or *somewhat effective* in helping them.

Transfer Goals: Table XVIII shows that 76.2% felt that Westchester Community College had been *very effective* in helping them to *Transfer to a Four-Year Institution*.

The graduates also were asked how effective the college had been in helping them to achieve their goal of *Meeting Professional or Graduate School Requirements*. Of those who consider it a goal 67.5% felt Westchester Community College had been *very effective* in doing so, as shown in Table XVIII.

In terms of very effective responses, the highest marks were given to Attaining Skills Useful on a Job (63.2%), Attaining a Degree Required for a Job (62.7%), Improving Professional Status (60.2%), and Developing Idea of Career Goals (60.1%). The lowest was given to Improving Chances of Making More Money (56.0%).

Personal Goals

Personal Growth: Table XX lists the personal growth objectives to which the respondents gave the highest percentages of *very effective* responses. The top three were *Improving Self-Confidence* (67.8%), *Develop a Sense of Responsibility* (65.9%), and *Developing an Interest in New Ideas* (65.0%). *Improve Ability to Get Along With Others* (54.2%) received the lowest percentage of *very effective* responses.

Social and Cultural Goals

Of the graduates who included cultural and social enrichment as goals for attending Westchester Community College, *Appreciation of Art and Architecture* received the highest percentage of *very effective* ratings (47.4%) followed by *Appreciation of Theater* (40.4%), *Involvement in Social Activities* (39.5%), and *Appreciation of Musical Performance* (32.4%). Respondents felt that the college was least effective in supporting *Involvement in Political Activities* (31.3%) as shown in Table XXI.


