

ACHIEVEMENTS FOR 2012-2013

- Westchester Community College ranks among the 30 community colleges in the SUNY system: fifth in total credit FTE's for fall 2012, and first in non-credit enrollments. We had a Fall, 2012 headcount of 13,997 in credit classes, and 13,916 annual in non-credit courses.
- The College's physical plant consists of 218 acres which includes 21 buildings, approximately 25 acres of parking lots and approximately 22.7 acres of athletic fields. All our public facilities are handicapped accessible, and we continually seek improvements through our capital projects planning and implementation.
- In addition to the Valhalla campus the College has 30 off-campus sites offering courses to both credit and non-credit students. Since 1970, the College has offered classes in over 39 public schools from Yorktown to Yonkers, approximately 110 organizations in the For Profit, Not-for-Profit and Government Sectors, and 53 civic associations from the American Red Cross to the Yorktown Chamber of Commerce, in over 18 public libraries from Armonk to Yonkers, 26 hospitals, and 19 nursing homes. Accessibility is our watchword.
- Diversity of the student body: Over 53% of the total credit student body is female, and 56% are minority and Hispanic. In Fall, 2011, students enrolled at WCC were from 61 other countries.
- Westchester Community College has new and updated Transfer Agreements as of 2009-10 with the following: College of New Rochelle, Cornell University, Dominican College, Iona College, Mercy College, Morgan State University, New York Institute of Technology, Houghton College, Lehman College (CUNY), Mount St. Mary College, and SUNY Empire.
- Of the 2011 graduates responding to the annual graduate survey, 62.2% of the respondents were employed either full-time (64.0%) or part time (36.0%). Of those employed, 57.9% were employed in Westchester County and another 27.6% in New

York State, but outside the County. They work for virtually all major corporations, small businesses, government, hospitals, etc. in the County.

- The average full time salary earned by first-time employees in a new job, six months after graduation from the College is approximately \$35,848. The median salary is \$35,000.
- Number of programs of study at the College: 45 Degree programs granting an Associate Degree and 21 Certificate Programs.
- The public uses the College facilities for more than just educational courses. Last year • over 417,000 individuals used the facilities for meetings including the American Red Cross Association's "Lifeguard Training", the United States Department of Labor Women's Bureau "Training for Social Service Agencies To Serve Female Veterans", the BOCES "Young Authors Conference", the Association of Retarded Citizens Theater Program, meetings of the Westchester AYSO Soccer, seminars sponsored by the Rockland Economic Development Center, Ossining High School Regents Exam Testing, Environmental Seminars sponsored by the Westchester Chemical Society, the "Beacon Conference - 20th Anniversary Presentation", Westchester County Department of Health's many provider-training workshops, Men's Basketball Region XV Playoffs, The Theodore Young Community Center Day Camp, The Westchester County Charter Revision Committee Meeting, The Tappan Zee Health Management Presentation, The "Stand UP for Female Veterans Conference", The Successful Learning Center Presentation, meetings of the Westchester Photographic Society, the New York State United Teacher's Conference -- "Tell It Like It Is Listening Tour", the "Women's Empowerment Presentation", the ACE Leadership Seminar "A Council on Education", the Hudson Valley Blood Services Fall/Spring/Summer Blood Drives, the American Heart Association's "Basic CPR Training", the "NYS Media Arts Festival for High School Students", the White Plains Recreation Department's soccer practices and games, as a polling site for the Town of Greenburgh Elections, Westchester AARP's "Tax-Aide Training", the 2nd Annual Westchester Community College Student Film Festival, the "Westchester County Football Officials Association Conference", the Girls Inc. "LaTeenA Conference for High School Girls", the Ecuadorian Civic Association Soccer League, The Westchester County Association's "World Trade Council Program", Congresswoman Lowey's "3rd Annual Financial Aid Forum", WCC Math Club and WCC Chapter of Omega (Computer Science) Conference "STEM from Space War to Portal: Science, Technology, Engineering, and Math for Social media, Television, Entertainment, and Movies."
- Harold L. Drimmer Library is the focal point for the information and research needs of students, faculty, staff and administrators, and is open to the general Westchester County community. The library's resources and services range from media, to print and electronic books, subscription databases that include full-text newspaper and magazine articles to virtual reference services and online course materials. Due to our resourcesharing partnerships with SUNY and WALDO, we are able to provide extensive interlibrary loan services. Users can also search for resources in the Westchester County and the New York Public Library System.

- Faculty in the Computer Security and Forensics program established a boot camp program for students to prepare for the Microsoft Technology Associate (MTA) certification exam. MTA certification is a critical first step to employment in the area of cyber security.
- Faculty participated in a grant funded (by Con Edison) initiative to infuse sustainability throughout different curricula including Fashion Technology and Global Business in the Business Department. The final presentations led to a second round of funding for the initiative.
- Our faculty from many departments participated in outreach activities across the County. The participation included judging at the Tri-County Science Fair at White Plains High School, hosting tables at Engineering Expo and at our Open Houses, welcoming high school students at the annual Math and Computer Science on-campus "Mathfest."
- In response to the campus-wide interest in improving the First Year Experience of students, the College continues participation in a consultation project, Foundations of Excellence (FoE), through the John Gardner Institute to evaluate the policies, practices, services, and initiatives pertaining to first-year students.
- Since its founding in 1969, Westchester Community College Foundation has raised funds to meet student and campus needs. The Foundation's primary objective is to provide scholarship support for students, and for the past six years in a row has distributed scholarships to over 1000 students. Over the past year, the Foundation moved the scholarship application process online, which resulted in a doubling of scholarship applications.
- The Westchester Community College Foundation has revitalized the Alumni Association, which is now in full swing with more than 1,200 members participating in its online community and other events. These events include a Financial Education Day during which hundreds of alumni, students and members of the community attended financial literacy workshops.
- The growing reputation of the college as a center for immigrant education led to a \$300,000 challenge grant from the National Endowment for the Humanities to establish the Westchester Community College Humanities Institute. This recognition extends the vision of the Gateway Center to other academic programs on campus.
- The Westchester Community College Foundation again attracted approximately 1,500 members of the community to its events including Celebrity Salons and the recent President's Forum.
- The Office of College Relations is in the midst of an effort to direct more resources toward electronic communications by introducing new enhanced online publications, a redesigned college website (sunywcc.edu) featuring links to social networking sites, approximately 100 YouTube videos, and an active Facebook page (more than 13,000 "friends/fans").
- The Division of Student Affairs is committed to providing services and programs that promote the college's mission and academic goals. The Division has assisted students in developing educational plans that align with their interests, goals and abilities while empowering them to take an active role in their education and assume personal responsibility and accountability.
- The Career Center has been a participant in The Westchester Association, Recruit Westchester Program.

- WCC's Phi Theta Kappa, a national honor society, was the recipient of three national recognition awards. Was recognized as one of the top 100 Chapters overall. There are over 1300 chapters.
- The Registrar's Office automated the graduation application process and is implementing an online transcript request procedure.
- •
- The Counseling Department completed a New Holistic Divisional Assessment Plan and developed a new transfer workshop to better prepare international transfer students in completing their education.
- The Counseling Department provided accommodations and related services to over 1000 students with disabilities.
- The Counseling Department developed and presented "Transition from High School to College workshop" as an outreach to prospective WCC students and their families.
- The Counseling Department provided Specialized Counseling and Accommodations to blind, deaf, hard of hearing and students on the Autism spectrum to maximize their potential.
- The Office of Admissions collaborated with the Welcome Center where calls are being made to new students to review enrollment process and encourage earlier enrollment.
- The Office of Admissions expanded Outreach Efforts to community based organizations, veteran agencies and added high schools to their target list on data collected.
- The Admissions Office has partnered with <u>Y</u>onkers <u>P</u>artners in <u>E</u>ducation which assists Yonkers students in the college admissions process.
- The Westchester Events Board (WEB), the student run programming board at the college, was the second place recipient of the Excellence in Programming Award in 2012. The award is presented by the National Association of Campus Activities and recognizes a College in the Northeast region of the US for having the most outstanding programming board structure and student events.
- Transfer Office continues to work with 4 year institutions on refreshing and creating articulation agreements; instant admits (on-site admission);weekly live chat through MEEBO; workshop series for both day and evening students; Transfer Day (120 colleges participated); Spring Transfer event with 80 schools participating; Vassar Summer program 3 WCC students were admitted for this summer;
- AoS (Accent on Students those with less than a 2.0 cumulative gpa) continue individual intensive intrusive counseling: Interim Grade Reports at 8 weeks, 10 and 12 weeks; 1st AoS scholarship (2 scholarships awarded to 2 students who improved their academic record);
- Counseling and Student Development introduced 1st and 2nd generation of student advisement template which will serve as the key assessment tool for Middle States.
- JobSTAR successfully helped 29 students who completed their assigned programs in obtaining permanent employment.
- JobSTAR designed and implemented the programs described in a contract with the Department of Social Services (DSS) offering a total of 12 program sections that served a total of 195 customers. The contract required a minimum of 152 total customers. A

re-vamping of the Integrated Application for Today's Environment Program (formally the Computer Skill Enhancement program) was approved for Voc Ed status with the State of New York.

- The English Language Institute (ELI) has expanded its partnerships with community based organizations (CBOs) by offering classes at the Community Opportunity Center, a part of WESTCOP, in Tarrytown. About 150 additional county residents are being served in their neighborhood with high quality language courses. Through other arrangements with public libraries and other CBOs these classes are available in White Plains, Ossining, Port Chester, Mount Kisco and New Rochelle.
- The ELI continues partnering with local business to provide contextualized English language training in the workplace, currently in a supermarket and a large biotech firm.
- As part of a Gateway Center initiative, and in partnership with the Westchester Hispanic Coalition, the ELI is participating in Governor Cuomo's Office of New Americans (ONA) project which will provide 200 residents with contextualized English language and citizenship services. It has a large volunteer component which is being addressed primarily through high level ESL learners volunteering to help ONA participants.
- The Center for the Digital Arts summer youth, pre-college program offered full-day 3D Animation and Game Design, Multimedia Storytelling for Teens, and courses for 157 local Peekskill youth.
- The Center for the Digital Arts promoted student artwork in its robust marketing plan, including a newsletter which is distributed to 47,000 people per year.
- The Center for the Digital Arts established a multi-year digital media partnership and rental agreement with the SUNY Empire State College Arts and Technology Program.
- Mainstream received funding from the Westchester County Department of Senior Programs and Services to conduct exercise/fitness classes for seniors. Summer semester classes were added, and classes are now offered throughout the year and to teach 23 life enrichment courses tailored to meet the needs of the County's diverse senior populations.
- Mainstream continues to serve as the lead agency for the Northwest Region Livable Community Connection sponsored by the Westchester County Department of Senior Programs and Services.
- Mainstream continues to offer Operation Talent Bank (funded by the Women's Research and Education Fund) and Tax Preparer (funded by the Carl D. Perkins Vocational Training Act) skills training and job search strategies programs for unemployed older adults.
- Small Business Training for Mature Adults, a Mainstream course designed for older adults who want to learn more about starting their own businesses was offered in spring 2013 and will be offered annually.
- The Professional Development Center received approximately \$55,000 from the State University of New York to provide workforce development training to Westchester businesses in the healthcare and food and beverage sectors.
- New non-credit computer courses offered by the Professional Development Center include Exploring Your Digital Camera, Make the Most of Your iPad, Using Skype, Introduction to Twitter, Social Networking with LinkedIn, and Introduction to SQL.

- The Professional Development Center was funded by a Perkins grant to provide training to prepare individuals to achieve the National Word Readiness credential and improve their computer skills.
- The Yonkers Extension Center expanded student services including tutoring, placement testing, academic advising, financial aid advising, and career and transfer advising.
- The Yonkers Extension Center held two Open House events for prospective students in partnership with Admissions and Student Affairs.
- The Yonkers Extension Center reached 93% enrollment capacity in the Spring 2013 semester.
- The Yonkers Extension Center at Cross County Shopping Center continues its partnership with Westchester Family Services, RSVP of Westchester and AARP in offering the Work Search program which serves mature job seekers in Westchester County.
- Community Services has successfully partnered with Hilltop Hanover Farms to offer a non-credit certificate program in Sustainable Gardening to educate students on sustainable vegetable production.
- Community Services, in conjunction with The Native Plant Center, Go Native University (non-credit certificate program in Sustainable Gardening with Northeast Flora) has expanded significantly and now offers numerous courses which have been approved by ASLA (American Society of Landscape Architects) for Continuing Education credit.
- Community Services partnered with the New York State Library Association to train students to become NYS certified Library Technicians
- Community Services trained numerous students in Fiber Optics technology.
- Community Services expanded the Personal Fitness training program to offer additional continuing education credits for fitness professionals.
- Community Services offered continuing education credits for architects and engineers.
- The Gateway Center continues to solidify its presence in the community by creating new partners and deepening existing ones. During the academic 2012/13 The Gateway Center received a grant from the NY State Department of State to open an Office for New Americans Neighborhood Opportunity Center. In partnership with the Westchester Hispanic Coalition, Gateway will offer English Language instruction, naturalization application assistance and entrepreneurship education to 200 low income immigrants throughout the county.
- The Gateway Center coordinated the Hispanic Heritage Month Committee to organize various campus-wide events to celebrate Hispanic culture. In 2012 the committee hosted a week-long celebration that attracted over 100 students, faculty and community members to activities around film, music and the arts.
- The Center for Financial and Economic Education (CFEE) is dedicated to offering an array of financial education programs for the campus and for residents of Westchester County. With a goal of promoting economic advancement for our community, the CFEE has delivered personal finance workshops for over 1,200 students, faculty, alumni, and members of the public in its first year. Special workshops have been implemented for

ESL students and for at-risk students in government-funded programs such as TRIO and EOP.

- As a member of the Westchester Financial Education Alliance, the CFEE was the recipient of the 2012 United Way of Westchester Community Service award for its Financial Education Day. This event, opened to the public attracted over 300 participants and volunteers at a day long series of workshops, financial counseling and presentations in March 2013.
- In collaboration with local partners, Gateway to Entrepreneurship (G2E) developed and delivered a series of four workshops entitled "Small Business Success". In addition, G2E collaborated with the County Office of Economic Development and other partners to host a 2 part entrepreneurship conference. This "Grow" conference attracted over 100 participants in November 2012 and is scheduled to host the second part on May 3, 2013.
- The Welcome Center continues to offer free citizenship preparation classes and other various workshops and programs and educational resources that support the full integration of our county's immigrant population.
- The Welcome Center expanded its citizenship preparation and college information sessions to off campus locations, including public libraries and school districts.
- The Division of Continuing Education is working in partnership with the Admissions Department, the EOC, and the Westchester Library System to offer college information sessions for clients of the County Department of Probation. The goal of this program is to assist Probation Department clients to transition into college.
- The Ossining Extension Center began initiating a partnership with 1199, the health care union, to develop non-credit educational pathways for 1199 members.
- The Director of the Mount Vernon Academic Support Center received the Alan & Jacqueline Stuart Endowed Faculty Chair in Developmental Studies; they hosted an Endowed Chair Lecture to celebrate Caribbean Culture in April.
- The Mount Vernon Academic Support Center, working with the Valhalla Academic Support Center, completed its 3 year renewal process for international tutor certification. The Academic Support Centers are certified under the College Reading and Learning Association.
- The Mount Vernon Academic Support Center expanded tutoring hours in Yonkers Cross County to better serve students.
- The Extension Task Force continues to pilot new initiatives to improve student services, including more traditional open houses and the "Early Alert" pilot that connects at risk students with counselors.
- The Extension Services office successfully piloted the new "late start" 11 week session in Port Chester Middle School, offering opportunities for students who want to enroll after the semester has already begun.
- The Extension Services office continues to send technical assistants to the school-based extensions to assist and train faculty in the use of smart board technology.
- The Center for The Arts continued to expand its extensive summer youth pre-college program by offering three new programs: an Educational Engineering Summer LEGO

Camp; a Summer Art Institute for Teens; and a Portfolio/Digital Photography Program for Teens.

- The Center for the Arts expanded its extracurricular activities, inaugurating a new Artist In Residence Program (AIR). In her two-month residency, Polish artist Monika Zarzeczna engaged the community, discussing her artistic practice and the ongoing progress of her site-specific art installation.
- The Center for the Arts created a new community-based Open Studio Project, with the vision to provide access to space, technology and equipment to members of the Westchester community to gather and create art together. This opportunity attracts people who lack access to a large studio space or contact with the humanizing practice of engaging in creative and artistic endeavor in the community.
- The Center for the Arts researched and developed new offerings, expanding its Ceramics and Jewelry/metal programs, and in collaboration with Community Services, introduced a new series in creative writing (open to the community).
- The Health IT Grant Project concluded in March, 2013. Over the 18 month course of the grant period, 181 participants enrolled in this 6-month Health Information Technology Program; over 80% of the participants successfully completed it. The Health IT Program will continue post-grant, and will be jointly sponsored by the Professional Development Center and Mainstream.
- The G2E and Mount Vernon Center offered the 2012 Entrepreneurship Summer Academy; now in its 7th year, the Academy is offered in partnership with the Mount Vernon Youth Bureau and the Network for Teaching Entrepreneurship, and provides a six week "Biz Camp" experience for Mount Vernon high school students. The Academy is grant supported, with funds from the Davis Entrepreneurship Programs and the Skirball Foundation.
- The Division worked in partnership with the Network for Teaching Entrepreneurship (NFTE) to host a county-wide Business Plan Competition. This initiative brings high school competitors from across the county and their teachers to the college; the competition is judged by members of the regional business community.
- The Division continued to work with the County Probation Department to provide Information Sessions and a pathway for probation clients to pursue non-credit workforce credentials at the college.
- The EOC provided tuition-free academic and vocational training to seven hundred sixteen (716) underserved community residents, enabling them to develop competencies and obtain national, state or industry certification in their selected fields so they are more competitive in the labor market. Fifty-five percent (55%) of the students participated in academic programs designed to develop English language skills, prepare for the high school equivalency exam and/or obtain skills required for success in college level courses.
- EOC received a multi-year Supplemental Assistance and Nutrition grant in the amount of \$300,000 through the SUNY Research Foundation to provide case management support and placement services to students who receive food stamps. The purpose of the program is to respond to the service needs of students to support their success in becoming fully self-supporting.

- As an official GED test site, the Educational Opportunity Center tested 428 community residents to date and expects to test an additional 150 individuals by the end of the academic year to help them obtain their high school equivalency diplomas.
- EOC sponsored its first International Day on site, showcasing the talent, skills and engagement of students in the English for Speakers of Others Programs while celebrating the diversity of backgrounds and cultures of our student population.
- EOC offered an EKG/Phlebotomy course as an enhancement to the Certified Nurse Aide training program for advanced students. Students who completed this course received better jobs and higher pay than the nursing students who did not enroll in this course.
- In an effort to promote a sense of community and encourage students to read and develop analytical skills, the EOC participated in the campus wide Common Read project. The book, The Other Wes Moore was incorporated into the GED curriculum and distributed to students throughout the Center. EOC students participated in the essay contest sponsored by the First Year Experience Committee.
- EOC continued to provide instruction and comprehensive support to English language learners through a continuum of ESOL offerings which included basic ESOL for beginners, English for the Workplace and English for Business and Health Careers for intermediate and advanced students, respectively. The programs focused on the acquisition of employment related language and provided students with the skills needed to enter into and succeed in the workplace.
- The EOC collaborated with the Westchester/Putnam One Stop and Westchester Community Opportunity Program to provide free tax preparation services to low income community residents on site. A total of 532 tax returns were prepared and the total amount of refunds issued was \$859,129.
- EOC collaborated with three organizations, Dress for Success, Career Closet and Career Gear to provide students with work appropriate clothing. A total of 88 students received professional attire to prepare them for the workforce.
- EOC administered TABE Adaptive tests on-line for the first time which resulted in a streamlined and more efficient process for assessing the academic skills of EOC applicants.
- Students studying to obtain their equivalency diploma at the EOC actively participated in webinars, video conferences, and educational exchanges with school districts nationwide, NASA, the Smithsonian, and new partner organizations including the St. Louie Higher Education Consortium and the World War II Museum in New Orleans. The video conferences focused on a wide range of topics in the sciences, social studies, multiculturalism and literature. Student engagement, test scores and the pass rate on the GED test continue to improve as a result.
- Through EOC's College Connection's Initiative (CCI), low income students who were interested in attending college were provided with the information they needed to make informed decisions about college enrollment. In addition, they received academic preparation in the Center's College Prep Academy, participated in virtual and "live" college visits and tours, and workshops on such topics as goal-setting, note-taking, time management and study skills. They were also given assistance in applying to college and for financial aid.

- The Student Center expansion was completed in January, 2013. The new facility design supplements existing activity and enhances student life.
- The Information Technology Department developed the new SUNY Financial Aid Award letter designed to provide potential students with a complete picture of expenses and financial aid they'll receive for attending school.
- The Information Technology Department in cooperation with the Admissions Department implemented an online admissions application which streamlines the student application process.
- The Information Technology Department implemented a major registration system upgrade, including People Soft Campus Solution 9.OR28.
- The Information Technology Department completed the upgrade of our IT Helpdesk and Asset Management System.
- The Information Technology Department is piloting a new print management system on all student printers. The focus of this system is to reduce the amount of wasted paper and reduce overall printing costs.
- The Information Technology Department continues to expand our implementation of server virtualization. This project has reduced the number of required physical servers, which in turn has reduce energy consumption and cooling costs.
- Information Technology, in cooperation with Media Services and Instructional Technology, added new SMART rooms on the Valhalla campus.
- The Information Technology Department is in the process of implementing SUNY's new DegreeWorks application. This application will be used throughout the entire SUNY system and is designed to enhance the student's ability to graduate and transfer between SUNY institutions.
- The Information Technology Department performed a major upgrade to the College's phone system, which included the implementation of Voice over IP for all extension sites.

NEW INITIATIVES FOR 2013-2014:

- Two new credit programs have been approved: AS in Environmental Studies and an AS in Environmental Science.
- WCC is scheduled for its 10-year reaccreditation visit by the Middle States Commission on Higher Education, scheduled for spring 2014. The College has launched the process for the research and preparation of the self-study document.
- The Center for the Digital Arts will celebrate its 20th year of operation during the 2013-14 academic year with exhibitions, special events and faculty historical presentations.
- The Center for the Digital Arts will continue the 2nd series of a five year marketing campaign Creating Art in the Digital Age, to build enrollment in our credit and non-credit offerings.
- The Center for the Digital Arts will continue collaborating with local community based organizations and the Educational Opportunity Center to encourage local youth to prepare and attend college.

- Mainstream will continue implementation of its new initiative designed for adults 50 and older to enter college for the first time or re-enter after a break from prior studies. Oncampus courses and services will enable students to successfully enter, or re-enter, college in order to work toward a credit certificate or completion of their Associates degree.
- The Professional Development Center is working with SUNY on a statewide TAACCCT grant which will enable us to partner with our advanced manufacturing employers and provide non-credit advanced manufacturing training for individuals who wish to enter this field.
- The Professional Development Center is working closely with the Hudson Valley Economic Development Corporation and other business organizations to support their efforts and expand services to the business community.
- The Professional Development Center is working on a number of initiatives to expand the scope of its training and training-related offerings for the business community.
- The Gateway Center through the English Language Institute will serve as a Neighborhood Opportunity Center for the NY Office for New Americans.
- Gateway to Entrepreneurship will partner with the Mount Vernon Youth Bureau and the Mount Vernon Extension Center to offer the Entrepreneurship summer Academy to high school students.
- The Center for Financial and Economic Education (CFEE) will continue to target personal finance training for ESL students by initiating a new series of workshops to teach the fundamentals of budgeting, saving, and managing credit and debt.
- The CFEE will expand offerings to the community at large by offering personal finance workshops in the summer and fall of 2013 and by repeating Financial Education Day, a half-day workshop open to the public, in 2014.
- The Welcome Center will expand initiatives in support of enrollment activities at the College.
- The Welcome Center will develop new programming in response to the expressed needs of immigrant-serving CBOs.
- Community Services will continue to offer continuing education professional development hours to licensed architects and engineers, allowing them to maintain licensure.
- Community Services will continue to expand Go Native University in partnership with the Native Plant Center to offer additional Continuing Education credits for Landscape Architects.
- Community Services will continue to expand leisure and enrichment programs to meet the needs of the community.
- Community Services will create the Center for Coaching Mastery at Westchester Community College.
- Community Services will reinstate the pesticide and turf management program.
- Community Services will continue to expand Green and Sustainable Living programs.
- The college will continue to expand its innovative scheduling of credit classes to better serve adult students who work or have other obligations. We'll offer classes Friday nights and Sundays at the Ossining Center, 7 week accelerated courses at Yonkers/Cross County, Lakeland HS and Port Chester MS, and early risers program at

Cross County and Ossining, and an expanded late start 11 week session at Port Chester MS.

- Late start classes in Port Chester, for those students who wish to enroll after the semester has begun, will expand from 2 to 4 days per week.
- The New Rochelle Extension Center has been relocated to Ursuline High School, increasing the number of classrooms and access to technology.
- The Ossining Extension Center will expand its non-credit healthcare programs by offering an RN Refresher course for registered nurses who want to re-enter the nursing workforce.
- The Ossining Extension Center will offer a new Medical Interpreter program beginning Fall 2013.
- The Ossining Extension Center will expand student services for the non-credit healthcare courses.
- The Mount Vernon Academic Support Center will collaborate representatives from Early College High School (ECHS) and White Plains High School (WPHS) in creating an enhanced summer orientation program for students who plans to enroll at Westchester Community College. Through a Westchester Community Foundation grant, students from these schools have the opportunity to participate in a comprehensive college transition program.
- The Mount Vernon Academic Support Center will work collaboratively with the Developmental Education Council to meet the Graduation, Achievement, and Placement (GAP) Program requirements mandated by state legislation.
- The Yonkers Extension Center will continue to expand student services implementing student service events and programming.
- The Yonkers Extension Center will partner with the Cross County Shopping Center to host job fairs for student employment opportunities.
- Center for the Arts will continue to explore innovative ways to expand community development and extracurricular activities for community building in its ceramics and jewelry/metal programs.
- Center for the Arts will continue to promote its digital art and photography students' achievements with off-campus exhibition opportunities. The Center will also continue developing partnerships with photography professionals to provide real-world knowledge and experiences for students through lectures, workshops and portfolio reviews.
- Center for the Arts will continue to expand its successful Educational Engineering LEGO Camp program, to include Architecture, Physics, and Design. While fostering the qualities of inquisitiveness, self-reliance, and self-confidence, the program will also emphasize professions in these disciplines.
- The Division of Continuing Education will continue its relationship with the County Probation Department to provide information regarding educational pathways for their clients.
- The Division of Continuing Education will continue to work with the Network for Teaching Entrepreneurship to host an annual county-wide competition.

- The Division of Continuing Education will collaborate with The Foundation to identify sustaining funding for entrepreneurship youth activities (Entrepreneurship Summer Academy, etc.)
- Expanded academic and student support services as well as increased faculty development are being planned for the Extension Centers both high schools and hubs.
- We will offer ESL courses tied to job preparation in both the health care area and in landscaping/horticulture.
- A stronger WCC-BOCES partnership for career and technical programs is planned.
- EOC will implement a Patient Care Technician program to provide opportunities for entry-level health care workers to earn higher wages and advance in their careers.
- EOC will modify its curriculum for high school equivalency testing to meet the new standards promulgated by the New York State Education Department and to ensure students have the computer literacy skills and competencies needed for on-line testing.
 EOC will develop its capacity and to administer and implement on-line high school equivalency tests. Software in the ATTAIN Lab will be upgraded to conform to the new high school equivalency exam.
- The Educational Opportunity Center will fully implement the Supplemental Nutrition Assistance Program and provide case management support and services to 150 food stamps recipients who are enrolled in training.
- EOC will upgrade the software for Medical Billing and Coding Program and provide professional development for faculty to ensure that students are trained on the most advanced applications used in the industry.
- EOC will provide pre-summer and summer programs for ESOL students to support their advancement into higher level programs in the fall; and it will provide training for accelerated GED students to help them obtain their GEDs well before the end of December, 2013 (the current exam expires).
- EOC will increase its capacity to provide students with a CDL license with airbrakes endorsement through the Commercial Driver's License Program.
- To increase employment opportunities for students, EOC will explore and develop new partnerships with employers and/or unions.
- The College Connections Program will be expanded to provide a broader array of services to all EOC students and particularly to those who are college bound.
- Information Technology will upgrade PeopleSoft Finance 9. To PeopleSoft Finance 9.2.
- Information Technology will upgrade PeopleSoft HR 9.0 to PeopleSoft HR 9.2.
- Information Technology will continue to migrate the phone system to Voice over IP to improve service quality.







Under the guidelines set forth by the federal *Student Right to Know Act*, the graduation rate for first-time, full-time, degree-seeking students in the Fall 2006 at Westchester Community College is **11.4%**.

The success rate for students recognizes that many students come to the community college with the intent of transferring before degree completion or may take longer to graduate. With these factors in mind, the success rate for the fall 2006 cohort is **56.7%**.


