

**NURSING COLLABORATION AGREEMENT
WESTCHESTER COUNTY COMMUNITY COLLEGE
AND
PACE UNIVERSITY**

The Westchester County Community College ("COLLEGE") and Pace University for its Lienhard School of Nursing, College of Health Professions ("Pace" or the "University") have entered into this Nursing Collaboration agreement (the "Agreement"), so that students enrolled in the Associate in Applied Science (A.A.S.) in the Nursing Program at the COLLEGE may be considered for admission into the Bachelor of Science degree in Nursing program for registered nurses (RN to Bachelor of Science with a Major in Nursing Online Program) at the University. The program governed by this Agreement shall be known as "The Pace Nurse Connect Program".

This agreement applies to students who have been identified by COLLEGE as beginning their nursing degree as of Fall 2019 and who have met all the requirements and conditions set forth below.

A. REQUIREMENTS FOR ADMISSION

1. Graduate from the A.A.S. in Nursing program from COLLEGE.
2. Successfully pass the registered nurse licensure examination at the conclusion of the first semester at the University.
3. Complete the Nursing Collaboration Agreement Intent Form prior to graduation from COLLEGE.
4. Meet all other eligibility requirements that apply to all students as determined by the University in its sole, exclusive, and confidential discretion.
5. Enroll in the University's RN to Bachelor of Science with a Major in Nursing Online Program for registered nurses within one year of graduating from the A.A.S. in Nursing program from the COLLEGE.
6. Meet with the University's RN to Bachelor of Science with a Major in Nursing Online Program staff to discuss the application process.

B. MATRICULATION

1. Notwithstanding any term or condition of this Agreement to the contrary, matriculation at the University will be on a space- and resources-available basis with the possibility of deferred enrollment.

To facilitate the transfer of the Westchester County Community College graduates to the University, the parties agree to the following:

C. OBLIGATIONS OF THE UNIVERSITY:

1. To provide a letter of admission and program-to-program information to the COLLEGE Director of Nursing for all COLLEGE students who are deemed eligible for admission to Pace under this agreement. For Pace admission, such students must satisfy all conditions set forth in Paragraph A. COLLEGE students under this agreement are governed by the Pace degree requirements in effect at the time of their Pace matriculation.
2. To maintain a database of student contact information who have completed the Nursing Collaboration Intent to Enroll form.
3. To use commercially-reasonable best efforts to the end that students will receive full consideration for Federal and state financial aid upon matriculation at Pace, provided they complete the financial aid process and meet required deadlines.
4. To provide students the RN to Bachelor of Science Major in Nursing Online Program tuition rate in effect at the time of matriculation.

5. Guarantee admission to eligible students who enroll within one (1) year of completing their associate degree.

D. OBLIGATIONS OF DEPARTMENT OF NURSING OF WESTCHESTER COMMUNITY COLLEGE:

1. To publicize this Nursing Collaboration Agreement to prospective students in their promotional materials and to inform matriculating students of their opportunity for admission to the University under the conditions of this Agreement. Notwithstanding any term or condition to the contrary contained in this Agreement, COLLEGE shall not: (i) distribute any University-related marketing in any form, including but not limited to translated versions of such materials, without prior review and written approval by University of the English-language versions of any such materials; or (ii) distribute any other documents or materials describing University, including but not limited to its programs, facilities, policies, procedures, standards, fees and expenses, unless such materials have been reviewed and approved in advance by University in each instance; or (iii) make any representations relative to University which conflict with the materials provided by and/or approved by University; or (iv) make any promises or representations regarding University relative to matters which are not expressly covered in the materials provided and/or approved by University, without first obtaining University's written consent. COLLEGE hereby warrants to University the accuracy qua translation of any COLLEGE-fostered translation of such materials and COLLEGE agrees to be responsible for any complaints or claims brought against COLLEGE or University from prospectively eligible students or other third parties arising from any inaccuracies in such COLLEGE-fostered translation of such materials.

2. To receive and distribute to eligible students the admissions letter with attachments provided by the College of Health Professions.

3. To provide opportunities for representatives of the University's RN to Bachelor of Science with a Major in Nursing Online Program to meet with all eligible Associate degree enrollees admitted under this agreement.

E. JOINT OBLIGATIONS:

1. Appropriate officials from each institution will review this agreement annually and make any changes that are mutually agreed to by the parties as needed. No changes shall become effective unless expressed in writing and signed by representatives from both parties.

2. Each institution will designate a representative who will coordinate and monitor the Nursing Collaboration Agreement.

3. To the extent authorized by applicable law and University policy, exchange data and documents that will contribute to the maintenance and improvement of this agreement, enhance the transfer process, and promote effective cooperation between institutions.

4. The parties agree to cooperate with each other in connection with any internal investigations by COLLEGE or the University of possible violation of their respective policies and procedures and any third party litigation, except that the University shall not be required to have any contact with any Union or Union representatives of COLLEGE's employees or subcontractors or participate in any Union grievance or other proceedings relative to COLLEGE's employees or subcontractors except as a fact witness.

F. TERM OF AGREEMENT:

1. This agreement will automatically renew unless terminated by either party in accordance with the provisions of this paragraph.

2. Either party may terminate the Agreement at any time by written notice at least one year in advance of the effective date of the termination. It is understood that such termination will not apply to students already accepted to Pace under the terms of this Agreement, even though not yet enrolled.

G. MISCELLANEOUS:

1. It is understood and agreed between the parties that the Agreement is not intended to nor does it create an employment contract between the University, on the one hand, and COLLEGE and any of its employees, on the other, nor does it create a joint relationship or partnership between the parties hereto. Neither COLLEGE nor its employees are entitled to benefits that Pace provides for University employees. COLLEGE's relationship to the University is solely and exclusively that of an independent contractor. Except as specifically permitted in this Agreement, neither party shall use the name or trademarks of the other party or incur any obligation or expense for or on behalf of the other party without the other party's prior written consent in each instance.
2. During the course of performance of the Agreement, either party (the "Receiving Party") may be given access to information that relates to the other party's (the "Disclosing Party") past, present and future research, development, business activities, products, services, technical knowledge, and personally identifiable student and employee information, or protected health information ("PHI")/electronic protected health information ("ePHI"). All such information shall be deemed to be "Confidential Information" unless otherwise indicated by Disclosing Party in writing at or after the time of disclosure. Receiving Party may use the Confidential Information only in connection with the specific duties authorized pursuant to this Agreement. Access to the Confidential Information shall be restricted to those of Receiving Party's personnel, representatives and consultants on a need-to-know basis solely in connection with Receiving Party's internal business. Receiving Party further agrees that it shall (i) take all necessary steps to inform any of its personnel, representatives, or consultants to whom Confidential Information may be disclosed of Receiving Party's obligations hereunder and (ii) cause said personnel, representatives, and consultants to agree to be bound by the terms of this Agreement by executing a confidentiality agreement containing the same restrictions contained herein or some other method reasonably acceptable to Disclosing Party. Receiving Party agrees to protect the confidentiality of the Confidential Information in the same manner that it protects the confidentiality of its own proprietary and confidential information of like kind, but in no event less than reasonable means. Receiving Party agrees to notify Disclosing Party of any unauthorized use or disclosure of Confidential Information and to take all actions reasonably necessary to prevent further unauthorized use or disclosure thereof. These requirements apply to any subcontractors or agents Receiving Party uses in the performance of its duties and obligations hereunder and it is Receiving Party's responsibility to assure that all such subcontractors and agents comply with all such requirements. The terms of this paragraph shall survive the expiration or termination of this Agreement.
3. Neither party shall assign this Agreement or its duties and obligations hereunder without the prior written consent of the other party.
4. Each party warrants that its performance hereunder shall be accomplished in compliance with all applicable Federal, State and local laws, ordinances, rules, regulations and codes.
5. Notwithstanding anything to the contrary contained in this Agreement, neither party shall be liable, nor shall any credit or other remedy be extended, for such party's failure, in whole or in part, to fulfill its obligations under this Agreement where such failure arises from or in connection with causes reasonably beyond such party's control, including, but not limited to, acts of God, flood, extreme weather, fire or other natural calamity, terrorist attack, any law, order, or regulation or action of any governmental entity or civil or military authority, power or utility failure, cable cuts, unavailability of rights-of-way, national emergencies, riots, wars, strikes, lock-outs, work stoppages, or other labor difficulties (each a "Force Majeure Event"). If a Force Majeure Event occurs during the term hereof, the materially adversely-affected party(ies) shall be excused from performance hereunder for the duration of the Force Majeure Event.
6. Except as may be preempted by federal law, this Agreement shall be governed by the laws of the State of New York, without regard to its choice of law principles. Litigation of all disputes between the parties arising from or in connection with this Agreement shall be conducted in a court of appropriate jurisdiction in the Borough of Manhattan, City of New York.

8. This Agreement, together with any exhibits or addenda annexed hereto, is the sole, complete, and exclusive expression of the parties' intent with respect to the subject matter hereof. Notwithstanding the foregoing, in the event of any conflict or discrepancy between the terms and conditions of this Agreement and those of any exhibit, rider, or addendum hereto, the terms of this Agreement shall control. This Agreement may be amended or modified only by a writing countersigned by authorized representatives of each party.

9. If a court holds any provision of this Agreement to be illegal, invalid, or unenforceable, the remaining provisions shall remain in full force and effect and the parties shall amend this Agreement to give effect to the stricken clause to the maximum extent possible.

10. Failure of either party to enforce any of its rights hereunder shall not constitute a waiver of such right(s) or of any other rights and shall not be construed as a waiver or relinquishment of any such provisions, rights, or remedies; rather, the same shall remain in full force and effect.

They will also assist you with the application process. Once you matriculate in the RN-BS Program, you will be assigned an advisor.

Transfer Articulation Agreement
Pace University RN to Bachelor of Science with a Major in Nursing Program

Effective September 2019

Pace University and Westchester Community College (the "College") hereby enter into the following agreement governing the matriculation of the College students at Pace University's (the "University") RN to Bachelor of Science with a Major in Nursing Completion Program. Admissions will be granted in accordance with the terms and conditions set forth hereinbelow to students who complete the Applied Associates Degree of Science in Nursing with a minimum Grade Point Average of 2.75 in the transfer curricula.

Pace University shall:

1. Accept College students as juniors provided they have achieved at their original institution a minimum grade of a "C" in all courses required for their major at University, have completed the courses set forth in Appendix A, which Appendix is hereby annexed hereto and by this reference made a part hereof, and satisfy all other University criteria for admission, as the same may be amended, modified, or withdrawn with or without notice.
2. Accept the required nursing courses at College that will be accounted for in the 30 Pre-Licensure credits awarded at Pace University as indicated in Appendix A – College Course Equivalencies and Pace Upper Level Courses.
3. Provide a list of Liberal Arts elective courses from which students should select to assist them in achieving the maximum of 68 transferrable credits from College.
4. After consultation with College, provide transfer guidelines that indicate courses the student should complete at the College.
5. Provide the opportunity for the College students to apply for early decision and acceptance to Pace University's RN to Bachelor of Science with a Major in Nursing Program starting in students last two semesters at the College. If accepted, students will be assigned to an academic advisor to assist in selecting courses that will best assist the students to maximize their potential 68 credit transfer from College. University's final acceptance decision is based in part upon receipt of the final College Official Transcript.

College shall:

1. Publicize the agreement and the Articulation Agreement Fact Sheet (Appendix B) among its students and faculty. Notwithstanding any term or condition to the contrary contained in this Agreement, College shall not: (i) distribute any University-related marketing in any form, including but not limited to translated versions of such materials, without prior review and written approval by University of any such materials; or (ii) distribute any other documents or materials describing University, including but not limited to its programs, facilities, policies, procedures, standards, fees and expenses, unless such materials have been reviewed and approved in advance by University in each instance; or (iii) make any

representations relative to University which conflict with the materials provided by and/or approved by University; or (iv) make any promises or representations regarding University relative to matters which are not expressly covered in the materials provided and/or approved by University, without first obtaining University's written consent. College hereby warrants to University the accuracy of any College-fostered translation of such materials, and College agrees to be responsible for any complaints or claims brought against College or University from prospectively eligible students or other third parties arising from any inaccuracies in such College-fostered translation of such materials.

2. Review the performance of the College students who intend to matriculate at University and to assess the students' academic preparation;

3. Allow a University representative to provide information to students at all of College's locations at least once per semester.

Each party shall:

1. Monitor the academic performance of students enrolling under this Agreement, identifying problems, and working cooperatively to adjust course sequence and content so that the students can transfer with no academic disruptions;

2. Arrange transfer meetings to update major course equivalencies between University and College.

3. Notify each other concerning any contemplated curricular changes that would affect the future of this agreement.

Miscellaneous

1. **Confidentiality.** During the course of performance of this Agreement, either party (the "Receiving Party") may be given access to information that relates to the other party's (the "Disclosing Party") past, present and future research, development, business activities, products, services, technical knowledge and personally identifiable student and employee information. All such information shall be deemed to be "Confidential Information" unless otherwise indicated by the Disclosing Party in writing at or after the time of disclosure. Receiving Party may use the Confidential Information only in connection with the specific duties authorized pursuant to this Agreement. The terms of this Section shall survive the expiration or termination of this Agreement. Notwithstanding the foregoing, it is acknowledged by the University that WCC is subject to the New York State Freedom of Information Law, as set forth in Public Officers Law, Article 6, which mandates public access to government records. Consultant hereby acknowledges and agrees that WCC shall have the right to disclose only such information as is required by law and that any such disclosure will be limited to the extent that the WCC considers proper under the law. If either party is directed or ordered to provide or disclose any information or matter by public authority or otherwise required to do so by law, such party shall promptly notify the party whose information is being provided or disclosed.

2. Termination. The Agreement may not be renewed without the written consent of the parties. Either party may terminate the Agreement upon thirty (30) days' prior written notice to the other party.
3. Compliance with Laws. Each party warrants on its behalf and that of its contractors, employees, and agents that it shall comply with all applicable Federal, State and local laws, ordinances, rules, regulations and codes.
4. No Employment Relationship Created. It is understood and agreed between the parties that the Agreement is not intended to nor does it create an employment contract between University, on the one hand, and College and/or any of College's employees, on the other, nor does it create a joint relationship or partnership between the parties hereto. The parties' relationship is solely and exclusively that of independent contractor. Except as specifically permitted in this Agreement, neither party shall use the name or trademarks of the other party or incur any obligation or expense for or on behalf of the other party without the other party's prior written consent in each instance.
5. Cooperation. The parties agree to cooperate with each other in connection with any internal investigations by University or by College of possible violation of their respective policies and procedures and any third party litigation, except that Pace shall not be required to have any contact with any Union or Union representatives of College's employees or subcontractors or participate in any Union grievance or other proceedings relative to College's employees or subcontractors except as a fact witness.
6. Force Majeure. Notwithstanding anything to the contrary contained in the Agreement, neither party shall not be liable, nor shall any credit or other remedy be extended, for such party's failure, in whole or in part, to fulfill its obligations under this Agreement where such failure arises from or in connection with causes reasonably beyond such party's control, including, but not limited to, acts of God, flood, extreme weather, fire or other natural calamity, terrorist attack, any law, order, or regulation or action of any governmental entity or civil or military authority, power or utility failure, cable cuts, unavailability of rights-of-way, national emergencies, riots, wars, strikes, lock-outs, work stoppages, or other labor difficulties (each a "Force Majeure Event"). Failure of either party to enforce any of its rights hereunder shall not constitute a waiver of such right(s) or of any other rights and shall not be construed as a waiver or relinquishment of any such provisions, rights, or remedies; rather, the same shall remain in full force and effect.

11. No Third Party Beneficiary Rights. This Agreement is not intended to and shall not be construed to give any third party any interest or rights (including, without limitation, any third party beneficiary rights) with respect to or in connection with any agreement or provision contained herein or contemplated hereby, except as otherwise expressly provided for in this Agreement.

Appendix B: College/Pace University Articulation Agreement Fact Sheet

Guaranteed Transfer Criteria:

Students who are graduating from College with an Applied Associates Degree of Science in Nursing are eligible for the College/Pace University Articulation leading to a Bachelor of Science with a Major in Nursing.

In this program, students who complete their College Associate Degree with a cumulative grade point average of 2.75 (or better) are guaranteed admission to Pace University RN to Bachelor of Science with a Major in Nursing Completion Program.

Standard Program:

Upon enrollment at Pace, students from College who are admitted bearing the Associates Degree of Science in Nursing are eligible to receive financial aid, based upon financial need and/or academic merit, on the same basis of any Pace University student. Students must file the Free Application for Federal Student Aid (FAFSA). The FAFSA must be completed and submitted to the Federal Government by the predetermined deadlines outlined by the United States Department of Education.

Transfer students from College are eligible for scholarships and grants based upon availability. More information regarding available grants and scholarships can be found at Pace University's Advancing Leadership and Scholarship office.

In addition to institutionally funded aid, students may qualify for need-based awards. Pace administers all Federal and State financial aid programs.

Cooperative and Education Career Services:

Upon enrollment, transfer students are eligible to participate in programs and activities offered by Cooperative Education and Career Services. These include (but are not limited to) the Campus Interview Program for graduating students, career counseling, access to job search access, and the Cooperative Education Program.

Additional Opportunities for Transfer Students

Upon enrollment at Pace University's RN to Bachelor of Science with a Major in Nursing Completion Program, students who have a Grade Point Average 3.0 or higher are eligible to take up to 4 graduate core courses (NURS 681, NURS 801, NURS 802, and NURS 803), which apply to both a Bachelor and a Masters Degree, depending on course availability and space. The tuition for these courses will be the same reduced tuition as all other courses in the Bachelor of Science with a Major in Nursing Program.
